## 5. **APPLICANT'S SUBMISSIONS**

5.1 The Applicant submitted, inter alia, as follows:

## "STATEMENT OF MATERIAL FACTS:

Notice received from VWSA of intended strike action by its workforce with effect 19.08.13 with unknown date of resumption.

All business operations are linked / tied in with VWSA production activities, i.e., no production at VWSA = no meaningful work for employees at Algoa Logistics.

Huge financial impact for the Company as there will be no income generated over the strike period.

Expenditures for the company are monthly paid (rent, instalments, etc) irrespective of income tied in with VWSA production.

## APPLICANT'S PAST RECORD:

Good - full compliance with all provisions of the Collective

Agreement.

## ANY SPECIAL CIRCUMSTANCES:

All business operations tied in with the Motor Vehicle Industry.

#### ANY PRECEDENT THAT MIGHT BE SET:

None - dependent on other industry.

#### **JOB PRESERVATION:**

Nil in short term – depending on the duration period of strike action in the Motor Industry.

#### **SOUND CONDITIONS OF EMPLOYMENT:**

Yes – Provisions of the Collective Agreement apply.

#### **POSSIBLE BENEFITS:**

No possibility at this stage of possible retrenchments.

#### FINANCIAL STABILITY:

Yes - no business income from clients for the entire duration of
