



## CIRCULAR TO THE INDUSTRY JOB GRADING FOR ABNORMAL LOADS DRIVERS & TANKER DRIVERS

- 1. Subsequent to the circular that was issued on 02 October 2018 regarding the job grading and implementation date of the Abnormal Loads Driver position, the Council has since conducted an independent review in respect of the outcomes of job grading for the Abnormal Loads Driver and the Tanker Driver positions. The purpose of the review was to assist the industry to identify differences between the two positions in so far as the nature and level of work performed by these two positions is concerned.
- Hence, the review considered the nature and level of work performed by the Abnormal Loads
   Driver and the Tanker Driver, and thereafter an assessment of the worth of these positions
   through a job evaluation exercise.
- 3. The positions were reviewed by an independent service provider based on the job content using the Paterson grading methodology.
- 4. Following a review of the content of the positions, it was found that there were minor differences in the nature of these positions, and in particular, the level of skills required to perform the job. Hence, both positions were graded at C1 with minimum wages of R 14 642.58.
- 5. In this regard, kindly find herein job descriptions, job grade and minimum wages of the Abnormal Loads and Tanker Driver positions. However, it should be noted that the qualification requirements apply to future employment and not to current employees.
