Re: Amendment to the Main Collective Agreement

1. As you may be aware clause 54 of the Main Collective agreement, dealing with industry trade unions subscriptions had been amended. From 1 March 2014 onwards trade unions will collect membership fees on the 7th of each month. The monies deducted by employers from the wages of party trade union employees must be paid into the bank account of the trade unions concerned.
