Circular to the Industry

1. Introduction: Changes to the Road Freight and Logistics Industry Provident Fund

This is notification that effective from 04 April 2012, the industry's Provident Fund will be administrated by SALT Employee Benefits in terms of section 13B of the Pension Funds Act (PFA). The Road Freight & Logistics Industry Provident Fund (RFLIPF), "the Fund", recently appointed SALT EB to perform back office administration services. The National Bargaining Council for the Road Freight and Logistics Industry (NBCRFLI), "the Council", continues to have a role in the administration of the RFLIPF in terms of section 13B of the PFA. This role is limited to member contact, collection of contributions and the enforcement function through its established network of offices across the country.

2. How is the Fund to be run?

Online Forms

The online D-form is to be completed for the submission of contributions. Once completed, the D-form is to be submitted directly to the NBCRFLI using the online method.

Monthly Contributions

The bank account details listed below are to be used when making monthly provident fund contributions. Your levy number is a requirement (reference) for the deposit to go through the online submission platform.

Front Office

In terms of the agreement between the Fund and the Council all 18 offices of the Council nationally will offer all member relations and contact services. Claims and withdrawal forms should be submitted through these offices. The contact telephone is: **0861(RFLIPF) 735473.**

Enforcement

The enforcement of collective agreements remains the jurisdiction of the NBCRFLI as the FSB may not enforce these agreements.

Disputes Resolution

Since the Provident Fund is registered with Financial Services Board (FSB), the Pension Fund Adjudicator's dispute resolution mechanism is now an option. However the Provident Fund, or its administrator, will need an opportunity to resolve queries before these queries are referred to the Adjudicator. The adjudicator's contact details are:
